Upon receipt of all of the required forms, we will send an electronic certification to your lender/servicer who will, in turn, send you either a notice to go to their website to submit an electronic signature or a paper Master Promissory Note (MPN) for your signature. **You must return the MPN directly to your lender/servicer before your Stafford loan can be guaranteed and approved.** If you completed a MPN in a previous year with the same lender, your loan will be guaranteed and approved when our certification is sent to your lender. If this is the case, you will not receive another MPN. Since the GradPLUS loan and private student loans are credit-based you must initiate this loan process directly with the lender of your choice and then list that information below so that we can send a school certification to your lender.
